REQUIRED DOCUMENTS:

- Application form, incl. description of the PhD project
- Curriculum Vitae (max. 2 pages in tabular form)
- Certificates (German university entrance qualification, university diploma, certificates of any other qualifying measures)
- Declaration of support by the PhD supervisor at a Bavarian state University – in case of a cooperating or combined doctorate between a University and a University of Applied Sciences, e.g. within the framework of a BayWISS-Verbundkolleg (<https://www.baywiss.de>), a joint declaration of support of both supervisors (PhD supervisor at the University and PhD supervisor at the University of Applied Sciences) is required including the following information:
 - ▶ The PhD candidate's scope of work is limited to activities related to the funded PhD topic and the scientific activities related to it. The University ensures that the teaching obligation is reduced to its lower limit according to §§ 4 and 5 of the Regulation for Teaching Assignments (LUFV).
 - ▶ Declaration regarding the amount to cover expenses of the PhD candidate to execute activities related to the PhD project (e.g. travel expenses, material expenses and publication costs, if necessary).
 - ▶ The PhD candidate will be given access to appropriate premises (i.e. equipped office spaces and labs, if required) as well as to the corresponding infrastructure at the host University or University of Applied Sciences.

The application documents have to be submitted electronically (1 PDF-document, max. 7MB) to fellowships@zd-b.de until 31.08.2017. Only applications fulfilling the formal requirements will be considered.

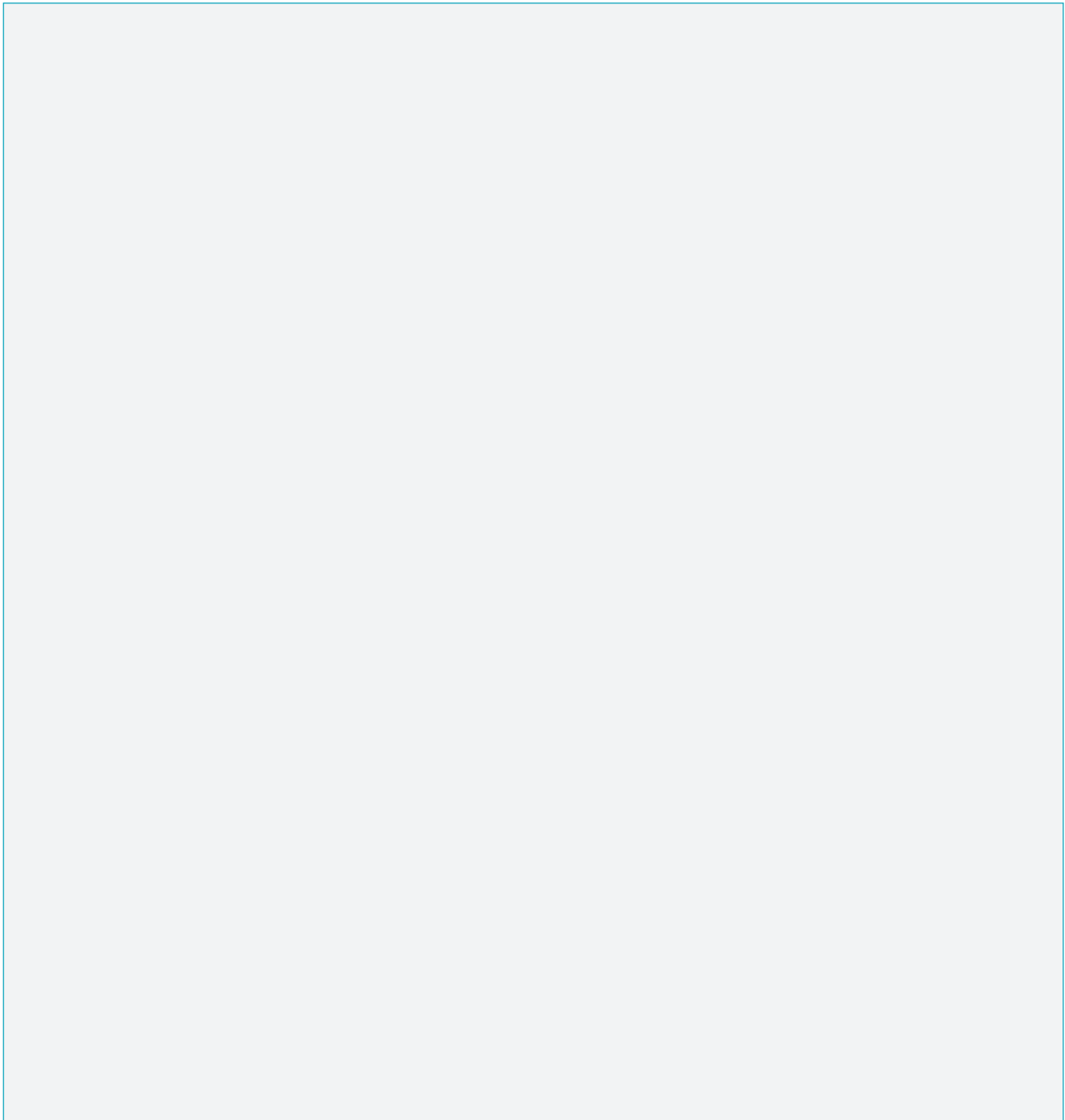
